

## **Ny forenklet claim procedure.**

PRD har ændret proceduren for claiming, så rettigheder fremadrettet kun skal bekræftes for så vidt, angår nye værker, der ikke tidligere er bekræftet.

Når rettighederne til et værk er bekræftet én gang på de enkelte sekundærtyper, sker dette i principippet en gang for alle. Det vil sige, at rettighederne ikke skal bekræftes yderligere bortset fra, hvis disse senere ændrer sig, fx fordi I har solgt rettighederne, aftalt en deling med en samarbejdspartner eller i tilfælde af en virksomhedsoverdragelse. I disse situationer er det til gengæld vigtigt, at I husker at registrere ændringen.

Første gang I bekræfter jeres rettigheder, er det nødvendigt at gennemgå alle jeres rettigheder og bekræfte alt på alle sekundærtyper. Vi ved at det for nogen er en meget stor liste at gennemgå, men fordelen er, at det fremadrettet, vil gøre jeres claim proces betydeligt mere enkel, da I herefter kun skal bekræfte nye rettigheder.

Den ændrede procedure indebærer ikke nogen ændring i ansvaret for claiming. Det er som hidtil jeres ansvar, at I kun bekræfter egne rettigheder, og den nye procedure indebærer tilsvarende, at det er jeres ansvar at gøre os opmærksomme på eventuelle ændringer i jeres rettigheder eller, hvis rettighederne ikke tilhører jer mere.

I vil to gange om året modtage en mail med påmindelse om at bekræfte rettigheder på evt. nye værker og opdatere rettigheder.

## **New simplified claim procedure.**

At the request from members PRD has changed the claim procedure, so that rights in the future must be confirmed only in relation to new works that have not previously been confirmed.

Once the rights to a work are confirmed on the individual secondary types, this is in principle done once and for all. This means that the rights do not have to be confirmed further except if they later change, e.g. if you have sold the rights, agreed on a split with a business partner or in the event of a business transfer. In these situations, however, it is important that you remember to register the change.

The first time you confirm your rights, it is necessary to review all your rights and confirm all items fully on all secondary types. We know that for some it is a very large list to review, but the benefit is that in the future, it will make your claim process significantly simpler, as you only need to confirm new rights.

The amended procedure does not imply any change in the responsibility for claiming. As under the old procedure, it remains your responsibility to confirm only your own rights, and the new procedure also means that it is your responsibility to notify us of any changes in your rights or, if the rights no longer belong to you.

Twice a year, you will receive an email with a reminder to confirm rights on potential new works and to update rights.
